Studies: I studied Political Sciences and Public Administration at the National and Kapodistrian University of Athens, Greece (1983). I obtained my **PhD degree** on Management and Economics from the Faculty of Law, Economics and Political Sciences of the same University in 1998 (Thesis title: "Efficiency Evaluation in the Organization and Financing of Hospital Services in Greece"). I have a **postgraduate diploma** in Hospital Administration from Athens National School of Public Health, Greece (1990) and a **Master's degree** in Healthcare Planning and Financing from the London School of Economics and Political Science (1993). As a **Research Fellow** (funded by British Council), supported the scientific activities (Health Units Management) of London School of Economics and Political Science, UK (1997). As a **Research Associate**, supported the scientific activities of Statistics in Biomedical Sciences of Hellenic Statistical Authority, Greece (1994) as well as supported the scientific activities of Informatics and Financial Management of Hellenic Management Association (EEDE), Greece (1991).

Professional Experience: My professional activity started in 1978 as an employee (accounting officer) in a private company in Athens (1978-1979) and continued with my appointment in the St. Sophia Children's Hospital, Athens, Greece as a senior administrative officer (1980-1993). In 1993, I moved to the Greek Ministry of Health and Social Security as a scientific member to support the team of experts appointed by the Minister of Health on issues of strategic health planning and health policy analysis (1993-1996). During 1998-1999, I moved to the private hospital "HYGEIA", in Athens, Greece as a management consultant. My professional activity continued as a CEO of Greek National Bank-owned hospital "Melathron Health Clinic - TYPET" (1999 - 2000), as a CEO of Onassis Cardiac Surgery Centre, Greece (2000-2002) and as a Managing **Director** and BoD Chairman of the NHS "Attikon" General Hospital (2002-2004). During 2006-2008 I worked as a consultant and **Research Fellow** at Bank of Greece being involved in various issues, mainly on health planning and financing. During 2009-2012, I worked as Secretary General of the Greek Ministry of Health, appointed through the e-gov system. During this period, I was involved in the planning and implementation of almost all health care reforms in Greece such as: (i) the Creation of a Unified Health Insurance Fund, (ii) the Reforms in the Greek NHS, (iii) Implementation of e-procurement materials and medicines drugs (iv) the Reorganization of the National Health System, (v) the implementation of double-entry accounting systems and balance sheets in all NHS

hospitals, (vi) the evaluation of all administrations through managerial indicators, (vii) the implementation of KEN-DRGs, (viii) NHS.net, etc.

From November 2018 until June 2019, I was appointed as **Chief Executive Officer (CEO)** of the State Health Services Organization (SHSO) of the Ministry of Health of Cyprus. SHSO is a new (2017) semi-governmental organization, under the responsibility of which belong all public hospitals, PHC health centers and sub-centers, ambulances and psychiatric services with their personnel. Some of the main CEO's activities are the submission and approval of 2019 budget and 2019-20 business plan, recruitment policy and decisions, appointment of directorate management, financial procedures, appointment and regulation of scientific councils, nursing standards etc.

Academic Positions and Teaching: 1. During 1996-2006, and while working at the Ministry of Health and private/public sector, I worked as Adjunct Professor at the Technological Institute of Athens (TEI Athens) (1996-7, 1998-1999), the National School of Public Administration (1999-2000), the Department of Business Administration at the University of Patras (2001-2006). More specifically, I taught the course "Health Economics", which is part of the BA degree programme in Nursing and the Master's degree in Public Administration. In addition, I taught the course "Health Services, Quality of Health Services, Health Policy and Health Economics" which is part of the BA degree programme in Business Administration, University of Patras and the course "Introduction to the management of health services" and 2. At the Hellenic Open University (2007-2008) in the Master's degree programme "Health Care Management". In addition, I was the academic coordinator at the Universities of Crete and Piraeus, as well as at the Greek program of the National Conservatoire des Arts et Métiers (CNAM), of the Master's degree programme "Health Services Management" (2005-2009) and Frederick University (Cyprus (up to 2009).

In June 2006, I was elected **Associate Professor** in Financial Management at the School of Management & Economics, Department of Health and Welfare Management, Technological Institute of Peloponnese, Kalamata, Greece. I taught the course "Financial Management in health sector", "Quality in health services" and "Costing analysis" which is part of the **BA degree** (2006-2009). In addition, I taught the module 60 "Health Care Management" of the **Master's degree programme** "Health Care Management" at the Open University of Cyprus (2009-2010), the courses "Administration of Health Services" and "Applied Methods of Organization and Management of Health Services" of the **Master's degree programme** "Public Health and Health Services Management" University of Crete, Greece (2009-2013), the course "Health Care Strategic

Publications: I have in total over 110 publications, in the following categories: 42 papers in international peer-reviewed journals, 28 in Greek peer-reviewed journals and 2 other papers and abstracts in peer-reviewed conference proceedings and volume of abstracts. In addition, I have authored or co-authored 11 books, 13 book chapters and 24 research & technical reports. Of these publications, 30 appear in PubMed and 30 in Scopus and EBSCO, with 200 citations in Google scholar, 400 in Research Gate and 200 in Scopus (see full list of publications on pages 7-21).

Papers and Posters Presented at Conferences: More than 80 announcements and posters were presented at national and international conferences, while I was member of the scientific or organizational committee in several other conferences (see detailed description on pages 15-21).

Participation in Research Projects: I have participated in over 40 research projects and studies, of which the vast majority as a project coordinator (15) or principal investigator (15). These include projects funded by EU, WHO, the Health Ministry of Greece, Private Companies, Greek Hospitals and Universities etc. (*see detailed description on pages* 21-23).

Research and Scientific Collaborations: Over the last 15 years, I have regular scientific and research collaboration with research centers in Greece and abroad, and close research links with other universities and institutes. (see detailed description on page 23).

Supervision of Doctoral and Masters Theses: Under my supervision, two post-doc and five Doctoral theses have been completed, three are in progress, while two more which have been completed, I was co-supervisor. Additionally, during the last 25 years I have supervised numerous Masters Theses at the Democritus University of Thrace, the Hellenic Open University, and the Open University of Cyprus. Some of these Theses have led to publications in peer-reviewed journals.

5. RESEARCH INTERESTS, PAST and CURRENT RESEARCH WORK: FUTURE PLANS

My research work began 25 years ago with my doctoral thesis on the topics of Hospital Management and Financing in order to reach the target of efficiency. It was the first study in Greece with full time series data on utilization and finance leading in regression analyses of average length of stay (ALS) and cost acting separately as dependent factors versus various indicators presenting as independent factors of all NHS Hospitals. The main findings showed strong correlation between ALS and cost (and vice versa), and both to the case mix and other factors related. Conclusion of the results showed that economies of scale have been reached at a size of 300 beds on average (above 200 and below 400).

Later on, it was published as "Striving towards Efficiency in the Greek Hospitals by reviewing Case Mix Classifications", Health Policy (2002). My research was also focused on hospital performance measurement and activity based costing in pediatric services with relative publications to the above as well.

At the same time, my research focused on health policy and reforms, acting also as consultant to WHO, EU, etc, leading to publications on the related issues, such as "the Evolution of Health Care in Greece. Starting a course of change", the International Journal of Health Planning and Management (1998). Further, my scientific interests took account business planning, quality and HR satisfaction, with relative publications.

My first permanent academic position let in a textbook on "Financial Management of Health Services" (2007). Upon taking up my duties at the Democritus University of Thrace, in November 2009, my research interests have extended to other topics focused on various health policy and management issues in collaboration with colleagues from Greek universities and research centers.

My appointment as Associated Professor on Health Service Management at (DUTH) Democritus University of Thrace (2009-2014) and then as MoH Secretary General (2009-2012) leads me to establish a permanent scientific team in order to work on health reforms and regulations. My second permanent academic position has led in a textbook on "Organizational Management of Health Services" (2014).

The setting up and operation of the esy.net (NHS network of utilization and financial data) gave me the unique opportunity to evaluate the whole system and publish reports and articles like "a three-year Performance of the NHS Hospitals in Greece" (Hippokratia, 2012), "restructuring the Finances of the Greek Health Care System in the Era of Economic Crisis (World J Surg, 2012) and "Health and Financial Crisis in Greece (Lancet, 2012).

After 2012, continuing my research on the above issues at DUTH, I investigated on my establishment of the DRG scheme in Greece, along with other innovations, e.g. e-procurement and generic medicines, leading to relative publications: "the contribution of generic substitution to rationalizing pharmaceutical expenditure in Greek public hospitals under recent economic crisis (Journal of Pharmaceutical Health Services Research, 2013), "reforming reimbursement of public hospitals in Greece during the economic crisis: Implementation of a DRG system" (Health Policy, 2013) and "public procurement of medical technology in Greece in an era of economic crisis" (Health Policy, 2013).

Becoming a Professor (8 years ago), I continued my research coordinating variously funded projects and theses (doc and post-doc). Four areas-topics were on my main scientific interests:

- 1. The unification of sickness funds, during my previous duties, and primary health care, through a huge project on that (2013), leading to a relevant e-book and publications such as "the introduction of Greek Central Health Fund: has the reform met its goal in the sector of Primary Health Care (PHC) or a new model is needed?" (BMC Health Service Research, 2014),
- 2. HR in Health, with two studies on demand (Health) and supply (Education), leading to a relative model specification (2014) and relative publications and announcement in international conference (2015).

- 3. Studies (2014-16) on the evaluation of the e-prescription system established at the Central Health Fund (EOPYY) in 2012 included 2013-15 data on prescriptions and their values per region-district, doctors' specialty, separation of branded, off patent and generic drugs, as well as their therapeutical category, and the level of patient co-payment, either in PHC or in Hospitals, leading in various publications (2016-18) e.g. Greek National e-prescribing system: preliminary results of a tool for rationalizing pharmaceutical use and cost, Global Journal of Health Science, ABC analysis: a tool of efficiency controlling pharmaceutical expenditure in Greek NHS Hospitals, JPHSR, etc,
- 4. Clinical protocols and DRGs, doctors' remuneration in PHC, hospitals' reorganization, etc.
- 5. Studies (2019-22) on the evaluation of hospital drugs, following be the evaluation of the 10-year e-prescription system, Horizon 2020 etc, primary care and public health projects.
